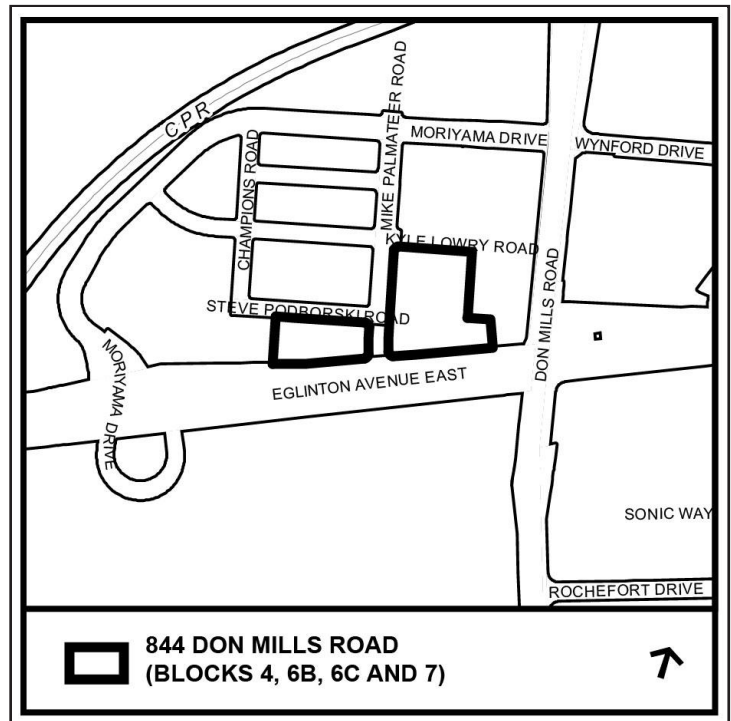
Meeting Background / Proposal

**Number of Dwelling Units: 2,540 Units
(total 4,974)**

**Parking Spaces: 1,265 Residential Parking,
33 Visitor Parking, 29 Office Parking, 7
Institutional Parking, 2,999 Bicycle Parking**
